Electronic Syllabus Information

The 2021 ISS electronic syllabus will include a written summary of each presentation delivered during the event. The primary presenter for each session is responsible for submitting the content on time and consistent with the guidelines.

The electronic syllabus with be made available online. No hard copies will be provided.

Instructions for Speakers

- All content will be submitted via an online portal. There are two separate portals for different presentation types:
 - o 1-hour instructional sessions, 15-minute paper sessions, and poster sessions:
 - Submit content via this portal
 - Pre-conference workshops:
 - Submit content via this portal
 - Please refer to the <u>program schedule</u> for information pertaining to your presentation's abstract
- Please also complete this survey to inform us if you will be virtual or in-person.
- Complete submissions are due no later than September 30, 2021, 12pm EDT.

We recommend creating a document with the sections outlined below in Word or another text-editing program. Creating a working document will allow you to confirm the character counts for each section and proof the text for spelling and grammar. For submission, you can then copy/paste the text into the online portal.

Different information is requested for each presentation type, as follows:

- 4-hour pre-conference (PC)
 - o Ten (10) post-test questions
- 8-hour pre-conference (PC)
 - Twenty (20) post-test questions
- 1-hour instructional course (IC)
 - All required paper content
 - o Any optional paper content you choose to include
 - o Any **graphics/figures** included in your paper
 - o Five (5) post-test questions
- 15-minute paper presentation (PS)
 - All required paper content
 - o Any optional paper content you choose to include
 - o Any **graphics/figures** included in your paper
 - o Two (2) post-test questions
- Poster presentation (PO)
 - Two (2) post-test questions

Separate submissions are required for each presentation.

Examples:

If you are presenting a **pre-conference session** *only*, you would skip to the **Post-Test Questions** section, as other paper content is not required.

If you are presenting a **1-hour instructional course**, you would submit all **required paper content**, any **optional paper content** you choose include, any **graphics/figures** included in your paper, and five **post-test questions**.

If you are presenting a **1-hour instructional course** and a **15-minute paper presentation or a poster**, you would make two separate submissions. The first would include all **required paper content**, any **optional paper content**, any **graphics/figures**, and five **post-test questions**. The second submission would include two **post-test questions** only.

Paper Content Required Paper Content

Course ID: You can find a listing of Course IDs by viewing the **Program Schedule**.

- Your ID will begin with "PC," "IC," "PO," or "PS," depending on your type of presentation.
- Please list the full ID, including the letters above.

<u>Title</u>: Enter the title of the session consistent with the abstract submitted and accepted. Session titles are limited to 120 characters including spaces (approximately 15 words).

<u>Authors</u>: Include each author with full names and accurate credentials. Limit to one primary/first author. Example:

- Primary Author: Suzy Smith, PhD, OTR/L
- Secondary Author: John Doe, DPT, ATP/SMS

<u>Learning Objectives</u>: Include at least three learning objectives consistent with those submitted with your accepted abstract proposal. Each learning objective must include a descriptor for the learners' behavior or action and an objective measure of achieving the objective. Examples:

- 1. Describe three reasons that...
- 2. Compare and contrast two different...
- 3. Discuss five options for achieving...

<u>Introduction</u>: Provide a brief introduction to the topic. The introduction must include at least 200 characters with spaces and cannot exceed 1000 characters with spaces (approximately 30-150 words).

Body: Provide a detailed summary of the information that will be presented during the session. The body of the paper must include at least 500 characters with spaces and cannot exceed 6000 characters with spaces (approximately 80-1000 words)

- Instructional course (IC) content should include reference to available evidence on the topic and clear, implementable recommendations.
- Paper session (PS) content should include a brief literature review, purpose, methods, results, and discussion.

Insert placeholder text using [brackets] in any areas where you would like graphics, charts, and photos. You will then upload these graphics separately per the Graphics Guidelines section. Example:

...As outlined in figure 1, the data show a strong correlation between both variables. [insert figure 1] This suggests that our interventions may have significant effects...

<u>Conclusion</u>: Provide the highlight or summary of the information included in the body of the paper. The conclusion must include at least 200 characters with spaces and cannot exceed 1000 characters with spaces (approximately 30-150 words).

<u>References</u>: Include a minimum of three references. All references must be formatted in APA style. Formatting guidance is available https://apastyle.apa.org/) or through these examples (examples taken from aforementioned APA style guide):

<u>Conflict of Interest</u>: Disclosure is required for all presenters. If no conflicts are present, please state "*No conflicts have been disclosed*".

Optional Paper Content

<u>Additional Resources</u>: Limited to a maximum of 700 characters with spaces (approximately 100 words). Additional learning resources include websites accessed or other resources that are not published.

<u>Acknowledgments</u>: Limited to a maximum of 500 characters with spaces (approximately 75 words).

<u>Contact Information</u>: Limited to a maximum of 500 characters with spaces (approximately 75 words).

Only provide contact information that you want to be made public.

Graphics/Figures

All graphics must be in the following formats:

- Portable Network Graphics (PNG): High Resolution 300 DPI
- Tagged Image File Format (TIFF): High Resolution 300 DPI
- Adobe Illustrator (All fonts saved as outlines)
- Adobe Photoshop

The graphic referenced in the text of your submission (e.g., "figure 1", "photo 2", etc.) must match the title and filename of graphic, chart, or photo uploaded.

No names or initials should be used in the text, tables, or illustrations. All people in images must have consented to the use of the image, and all children under 18 must have their faces blocked in the image.

The person submitting the information takes full responsibility for using all graphics, illustrations, and other images in the document.

Post-Test Questions

Provide **multiple choice questions** related to your presentation or poster topic and learning objectives. Depending on the presentation type, you must submit the following number of questions:

4-hour pre-conference (PC)	ten (10) questions
8-hour pre-conference (PC)	twenty (20) questions
Instructional course (IC)	five (5) questions
Paper session (PS)	two (2) questions
Poster (PO)	two (2) questions

Each question must include four possible responses (a, b, c, and d). Please indicate the correct response by writing "(correct)" after that response. Each question must include at least 50 characters with spaces and cannot exceed 500 characters with spaces (approximately 8-80 words).

Question Example:

- 1. "Which organ system does the condition 'osteoporosis' affect?"
 - a. Respiratory System
 - b. Skeletal System (correct)
 - c. Lymphatic System
 - d. Nervous System

Question Template:

- 1. Question...
 - a. Response A
 - b. Response B
 - c. Response C
 - d. Response D

Post-test questions should relate to the presentation content and learning objectives in order to test the participant's' understanding of the content. For additional guidance on crafting effective post-test questions, please refer to:
